We will not hold a goat for purchase until we have received both a signed contract and deposit. Please pay via "Friends and Family" or a fee of 3% will need to be paid by the BUYER prior to transfer of possession. **The balance of \$ _____ is due prior to the goat(s) leaving the possession of the SELLER.**

BUYER agrees to take possession of said goat(s) on this agreed upon **pickup date:** _____, within a maximum of 14 days after BUYER receives this contract OR at date of weaning. Failure to pickup by the above pickup date will result in a boarding fee of \$5/day/goat to be paid in full by the BUYER prior to transfer of possession.

Dogwood Honey Company Sales Policies

- The BUYER is required to pickup new goats at our farm. No meets or deliveries will be made. Exception is prearranged transport services.
- Goat(s) must be transported in an enclosed and ventilated space large enough for them to stand, turn around and lay down. Dogwood Honey Company reserves the right to deem the transportation method unsafe and turn away the BUYER without releasing the goat(s).
- The BUYER agrees to provide adequate shelter, food, fresh water and companionship for the goat(s) at all times.
- Farm tours will not be permitted due to strict biosecurity protocols. We will happily send you pictures and/or videos upon request.
- Pricing varies based on quality, traits and colorings of individual animals. Our prices are non-negotiable. As we continue to work towards milk stars in our herd, these qualities will be reflected in the cost of their offspring.
- Health and vaccination records will be provided to the BUYER.
- Kids are bottle-raised unless specified elsewhere.
- All kids will be appropriately disbudded, dewormed as needed, tattooed, banded for 24 hours (wethers) and vaccinated prior to leaving our farm. Records will be provided.
- ADGA registration paperwork or transfer of ownership form(s) will be given to BUYER.
- BUYER agrees to complete registration or transfer of ownership through ADGA at BUYER'S expense.
- Castrated goats, also known as wethers, will NOT come with ADGA registration papers and will NOT be tattooed
- BUYER will be provided with our grain mix to transition feed slowly over at least a week.
- SELLER guarantees said goat(s) is/are healthy at the time of sale and BUYER has the option to review the condition and health of the goat(s), including any on farm veterinary examinations, at BUYER'S expense.
- Should a doe/doeling be sold as a pet/non-breeding animal, no registration papers will be released or given to BUYER at any time.
- If said goat(s) is/are not picked up after 30 days of the agreed-upon pickup date the BUYER'S reservation will be forfeited, including all monies paid, and said goat(s) will be retained or placed for sale.
